

#### **Terms and Conditions:**

- EXCLUSIVITY: The VENUE may not administer the status of other appearances or performances made by any of the artists/bands/acts on this package. However, any appearances or performances made by artists/bands/acts in the Pomona area must be made known to the VENUE in the case of a conflict in ticket sales. If it is made clear that another appearance or performance negatively affects the sales of this agreed-upon event or show, the VENUE reserves the right to request the artists/bands/acts to drop either event or show but has no right to act upon it.
- 2) COVID SAFETY: This agreement is based upon the current 2024 recommendations for sellable capacity. If the government implements restrictions or recommendations on the operation, capacity, or admission procedures that would adversely affect this event, the ARTIST or representative thereof may discuss an alternative deal structure with the VENUE, rescind this agreement, and/or cancel this event without payment or penalty.
- 3) **PROMOTION:** The ARTIST and/or PROMOTER is responsible for frequently and assertively posting and promoting their event. All performers/artists should post on their socials along with the ARTIST and/or PROMOTER.

#### 4) LIABILITY:

- a) The ARTIST and/or PROMOTER along with the ARTIST and/or PROMOTER's agent, representative, affiliates, crew, and all other members shall be unequivocally responsible and liable for any and all property and equipment provided by the VENUE for the ARTIST and/or PROMOTER, (including but not limited to the event of a fire, proven theft, riot, or any damaging occurrence other than normal wear and tear or damage).
- b) Any direct or purposeful damages incurred upon The VENUE caused by the ARTIST and/or PROMOTER are to be appropriately compensated through the repair, replacement, and/or reimbursement of said damages provided by the ARTIST and/or PROMOTER.
- c) The VENUE is not responsible for any damages or loss of property of the ARTIST and/or PROMOTER, other artists/bands/acts of the event, or any members, crew, and affiliates involved.
- d) Damages or loss of property of the VENUE caused, directly or otherwise, by the audience shall be the responsibility and liability of the audience, not the VENUE, ARTIST, and/or PROMOTER.

#### 5) CANCELLATION:

- a) The ARTIST and/or PROMOTER may not cancel this Agreement except for the proven inability to perform due to sickness, accident, acts of war, acts of God, or other legitimate causes beyond their control.
- b) The VENUE reserves the right to cancel this event if two or more artists outlined in this agreement are unable and/or unwilling to perform as agreed.
- c) The VENUE reserves the right to cancel this event if any of the terms and conditions in this agreement are violated.
- d) There shall be no cancellation fees for any artist, promoter, or associates at any time. The VENUE is responsible for refunding all online tickets.

6) **PROFESSIONALISM:** The VENUE is a safe, no-nonsense venue.

- a) The ARTIST or PROMOTER and affiliates will <u>not</u> engage in, encourage, or permit the possession, consumption, or sale of **OUTSIDE GUM**, **ALCOHOL**, **OR DRUGS**, nor use **MARKERS**, **STICKERS**, or any other forms of **TAGGING/GRAFITTI** on the premises or property of The VENUE or Green Room.
- b) The ARTIST or PROMOTER and affiliates must carry themselves in a presentable and respectful manner on site. Any hate speech, violence (and its encouragement thereof), or derogatory and/or inflammatory language/behavior (includes and is not limited to offensive verbal comments or actions related to gender, sexual orientation, gender identity or expression, disability, size, ethnicity, or religion, deliberate intimidation, inappropriate/unwanted physical contact, or any hateful, violent, lewd or otherwise inappropriate behavior) will immediately result in the offender and their affiliates removed from the premises and BANNED from The VENUE.
- c) The ARTIST and/or PROMOTER must advance their members' and affiliates' names and sign this agreement to perform at the venue and enter its premises. Each artist/band/act is allotted one photographer, one merchandise assistant, and one guest per artist/band/act member. Guests must check in at the front of the venue and are not allowed in the Green Room.
- d) The VENUE has the right to drop an artist/band/act from the lineup if allegations of any hate speech, acts of violence, or use of derogatory, inflammatory language/behavior have been made against the artist/band/act.

\*Subject to change or be negotiated in a different verbal or physical agreement/contract. However, no agreement/contract shall be validated without the verbal or written consent of the venue owner.
